- CO.6** Compare and contrast evidence-based practices to address different types of bullying (physical, verbal, relational, cyber, sexual, prejudicial/identity-based).

- CO.7** Critique current practices to identify and discontinue ineffective, non-restorative approaches to addressing bullying.
- CO.8** Critique socialized beliefs and assumptions about the causes of bullying, including environmental and contextual, stakeholder motivations, and stakeholder personality traits.
- CO.9** Design a method for tracking bullying behaviors in order to make data-driven decisions that effectively address prevention, intervention, restoration, and reintegration.
